## CITY OF ZAVALLA ORDINANCE # 61

ORDINANCE REQUIRING ALL STRUCTURES WITHIN THE CORPORATE CITY LIMITS OF ZAVALLA, TEXAS TO BE CONNECTED TO THE THE PUBLIC WATER SUPPLY WITHIN THE CITY OF ZAVALLA, TEXAS, TO CONNECT TO THE SYSTEM; SETTING RATES FOR WATER SERVICE; PROHIBITING THE FUTURE USE OF WATER WELLS UNDER CERTAIN CONDITIONS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE; AND FOR REPEAL OF ALL INCONSISTENT ORDINANCES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ZAVALLA, TEXAS THAT IT IS IN THE BEST INTEREST OF CITIZENS OF THE CITY OF ZAVALLA THAT:

**SECTION 1-** From and after the effective date of this Ordinance, use of water wells within the city limits of the City of Zavalla, Texas, shall be, and the same is prohibited except as permitted in Section 2.

**SECTION 2-** The preceding Section 1 shall not apply to any buildings, house, or other structure ("Structure") all of which is **NOT** within the Corporate City Limits of the City of Zavalla. Existing wells, with no cross connection to the public water supply may continue to be used for watering of livestock and vegetation.

**SECTION 3-** If there are more than one Structure on a parcel of land, each Structure shall have its own connection to the Public Water Supply System.

#### SECTION 4- RATES

- a. A residential customer within the corporate limits of the City shall pay for monthly water service at the rate of \$15.00 for the first 2,000 gallons and 2.00 per thousand for the next 4000 gallons, 2.50 per thousand for the next 4000 gallons, 3.50 per thousand for the Remainder gallons,
- b. A commercial customer within the corporate limits of the City shall pay for monthly water service at the rate of \$15.00 for the first 2,000 gallons and 2.25 per thousand for the next 4000 gallons 2.75 per thousand for the next 4000 gallons 3.25 per thousand for the next 4000 gallons 3.75 per thousand for the next 2000 gallons.

1.50 per thousand for the Remainder gallons.

- c. Residential customers outside the corporate limits of the City shall pay the same rate .
  - d. Commercial customers located outside the corporate limits of the City shall pay the same commercial rate.
- **SECTION 5.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 6** If any section, subsection, paragraph, sentence clause, phrase or word in this Ordinance or application thereof to any person or circumstance is held invalid, such holding shall not affect the validity of the remaining portions of the Ordinance and the City Council hereby declares it would have passed such remaining portions of the Ordinance despite such invalidity.

## CITY OF ZAVALLA ORDINANCE NO. 61 (AMENDED)

ORDINANCE REQUIRING ALL STRUCTURES WITHIN THE CORPORATE CITY LIMITS OF ZAVALLA, TEXAS TO BE CONNECTED TO THE PUBLIC WATER SUPPLY WITHIN THE CITY OF ZAVALLA, TEXAS, TO CONNECT TO THE SYSTEM; SETTING RATES FOR WATER SERVICE; PROHIBITING THE FUTURE USE OF WATER WELLS UNDER CERTAIN CONDITIONS; PROVIDING FOR SEVERABILITY; PROVIDING FOR N EFFECTIVE DATE; PROVIDING A PENALTY AND FOR REPEAL OF ALL INCONSISTENT ORDINANCES.

BE IT ORDERED BY THE CITY COUNCIL OF THE CITY OF ZAVALLA , TEXAS THAT IT IS IN THE BEST INTEREST OF CITIZENS OF THE CITY OF ZAVALLA THAT ORDINANCE #61 BE AMENDED AS FOLLOWS TO WIT:

SECTION 1 -From and after the effective date of this Amended Ordinance, use of water wells within the city limits of the City of Zavalla, Texas, shall be, and the same is prohibited except as permitted in Section 2.

SECTION 2 -The preceding Section 1 shall not apply to any building, house, or other structure ("Structure") all of which is NOT located within the Corporate City Limits of the City of ZAVALLA Existing wells, with no cross connection to the public water supply may continue to be used for watering of livestock and vegetation.

> SECTION 3 If there is more than one (1) house or business on a parcel of land, each house or business shall have a separate water meter

#### SECTION 4 -RATES

- a. A residential customer within the corporate limits of the City shall pay for monthly water service at the rate of \$15.00 for the first 2,000 gallons and
  - 2.00 per thousand for the next 4000 gallons,
  - 2.50 per thousand for the next 4000 gallons,
  - 3.50 per thousand for the Remainder gallons.

- b. A commercial customer within the corporate limits of the City shall pay for monthly water service rate of \$15.00 for the first 2,000 gallons and 2.25 per thousand for the next 4000 gallons, 2.75 per thousand for the next 4000 gallons, 3.25 per thousand for the next 4000 gallons, 3.75 per thousand for the next 2000 gallons, 1.50 per thousand for the Remainder gallons.
- c. Residential customers outside the corporate limits of the City shall pay the same rate.
- d. Commercial customers located outside the corporate limits of the City shall pay the same commercial rate.

<u>SECTION 5</u> - All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 6 - If any section, subsection, paragraph, sentence clause, phrase or word in this Ordinance or application thereof to any person or circumstance is held invalid, such holding shall not affect the validity of the remaining portions of the Ordinance and the City Council hereby declares it would have passed such remaining portions of the Ordinance despite such invalidity.

SECTION 7 - Any person convicted of violating any provision of this Ordinance shall be assessed punishment in an amount not to exceed Two Hundred (\$200.00) Dollars. Said person (after conviction) shall be deemed guilty of a misdemeanor and each day during which a violation continues shall be considered a separate offense
