AN ORDINANCE

PROHIBITING THE COLLECTION OF SOLID WASTE WITHOUT A PERMIT OR CONTRACT WITH THE CITY OF ZAVALLA, AND PROVIDING A PENALTY NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00) FOR EACH VIOLATION.

WHEREAS, it is in the public interest and welfare to prohibit the collection of solid waste without a permit; NOW THEREFORE:

BE IT ORDANINED BY THE CITY COUNCIL OF THE CITY OF ZAVALLA:

SECTION 1. Except as other wise provided no person shall collect solide waste for a profit without:

- 1. Contract
- 2. Permit

SECTION 2. Any person may dispose of his or her solid waste in a lawful manner.

SECTION 3. Any person who shall violate any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof, shall be punished by a fine not to exceed two hundred dollars (\$200.00).
