AN ORDINANCE CHANGING THE SPEED LIMITS IN THE CITY LIMITS OF ZAVALLA.

Whereas, the City of Zavalla lies in a valley and to enter said City requires entering down steep hills and;

Whereas, the present speed limits are dangerous and a menace to safety of our citizens and the traveling public; and

Whereas the lowering of the school zone speed limit is necessary for the protection of our children.

THEREFORE be it ordained by the City Council of the City of Zavalla the speed limit of the City of Zavalla shall be;

City Limits on Highway 63 and 147 to school flashing lights 35 m.p.h., and 20 m.p.h. between flashing lights in the School Zone, 35 m.p.h through downtown Zavalla to intersection of Highway 69, and 35 m.p.h. from City Limits to City Limits on Highway 69.

ORDINANCE ESTABLISHING MAXIMUM SPEEDS OF MOTOR VEHICLES IN CERTAIN AREAS AS DESIGNATED

WHEREAS, The State Department of Highways and Public Transportation has made its recommendations to this Commission for such speed zone areas, and

WHEREAS, The City Commission of Zavalla has studied such recommendations and believe them to be realistic and proper for the City of Zavalla,

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Zavalla, that the maximum speed for these areas applicable shall be as follows:

U. S. 69

For traffic traveling south from the North City Limits of Zavalla (Hwy. Engr. Sta. 1169 + 29.3) to a point 503 feet north of SH 63 (Hwy. Engr. Sta. 1186 + 89.3 = 459 + 13.0) a distance of 0.333 mile the speed limit will be fifty-five (55) miles per hour in either direction.

From a point 503 feet north of SH 63 (Hwy. Engr. Sta. 1186 + 89.3 = 459 + 13.0) to a point 558 feet fouth of SH 63 (Hwy. Engr. Sta. 448 + 52.3) a distance of 0.200 mile the speed limit will be forty-five (45) miles per hour in either direction.

From a point 558 feet south of SH 63 (Hwy. Engr. Sta. 448 + 52.3) to the Zavalla South City Limits (Hwy. Engr. Sta. 396 + 63.8) a distance of 0.982 mile the speed limit will be fifty-five (55) miles per hour in either direction.

S. H. 147

From its intersection with SH 63 (Hwy. Engr. Sta. 31 + 58.8) to a point 87 feet west of FM 2109 (Hwy. Engr. Sta. 50 + 00) a distance of 0.349 mile the speed limit will be forty-five (45) miles per hour in either direction.

From a point 87 feet west of FM 2109 (Hwy. Engr. Sta. 50 + 00) to the Zavalla City Limits (Hwy. Engr. Sta. 80 + 58.8) a distance of 0.580 mile the speed limit will be fifty-five (55) miles per hour in either direction.

BE IT FURTHER ORDAINED that this ordinance shall become effective immediately upon approval and publication
